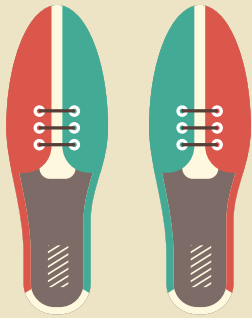
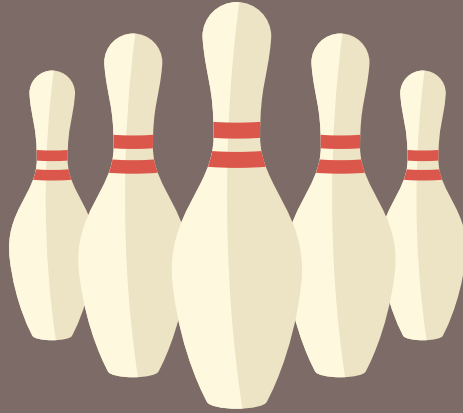

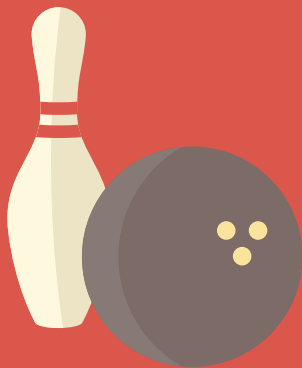

## ABOUT MOCK TRIAL

Proceeds from the Diversity Bowl support the Justice & Diversity Center's mock trial educational program, an inter-scholastic competition where high school students try a hypothetical criminal case provided by the Constitutional Rights Foundation. Mock trial helps transform students' lives by teaching invaluable skills, including public speaking, team work, and critical thinking. Students build their intellectual skills and gain confidence in their ability to present and support arguments. At the same time, mock trial is an excellent way to learn about the law and the legal system in a fun, creative, and challenging way.

Programs like mock trial open students' eyes to the possibilities offered by college, and potentially law school and a career in law.

## ABOUT SCHOOL-TO-COLLEGE

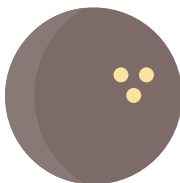
School-To-College (STC) is a free comprehensive high school pre-college program at The Academy of Arts and Science High School in San Francisco. By providing guidance, insights and opportunity for student in grades 9-12, STC gives students the tools they need to enter college. STC offers pre-college counseling, discounted SAT preparation courses, financial aid and scholarship counseling, college application assistance, college tours, and SAT/ ACT fee waiver services.

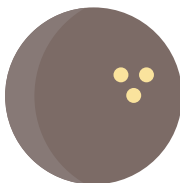

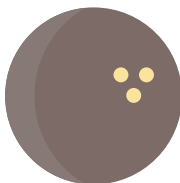

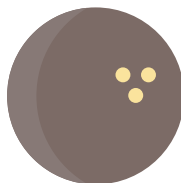
